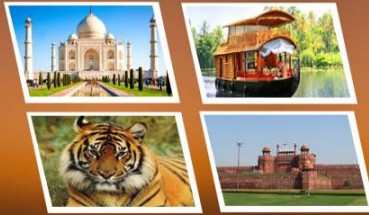

Eligibility

1. International travellers whose sole objective for visiting India is recreation, sight seeing, casual visit to visit friends and relatives, attending a short term yoga programme, medical treatment including treatment under Indian systems of medicine, business purpose, as attendant to e-Medical visa holder, attending a conference/ seminar/ workshop organized by a Ministry or Department of the Government of India, State Governments or UT Administrations etc. & their subordinate/ attached organizations & PSUs and no other purpose/activity.
2. Passport should have at least six months validity from the date of arrival in India. The passport should have at least two blank pages for stamping by the Immigration Officer.
3. International Travellers should have return ticket or onward journey ticket, with sufficient money to spend during his/her stay in India.
4. International Travellers having Pakistani Passport or Pakistani origin may please apply for regular Visa at Indian Mission.
5. Not available to Diplomatic/Official Passport Holders or Laissez-passer travel document holders.
6. Not available to individuals endorsed on Parent's/Spouse's Passport i.e. each individual should have a separate passport.
7. Not available to International Travel Document Holders.




