



#### Fligibility


- 1. International travellers whose sole objective for visiting India is recreation, sight seeing.casual visit to visit friends and relatives, attending a short term yoga programme, medical treatment including treatment under Indian systems of medicine, business purpose, as attendant to e-Medical visa holder, attending a conference/ seminar/ workshop organized by a Ministry or Department of the Government of India, State Governments or UT Administrations etc. & their subordinate/ attached organizations & PSUs and no other purpose/activity.
- Passport should have at least six months validity from the date of arrival in India. The passport should have at least two blank pages for stamping by the Immigration Officer.
- 3. International Travellers should have return ticket or onward journey ticket, with sufficient money to spend during his/her stay in India.
- 4. International Travellers having Pakistani Passport or Pakistani origin may please apply for regular Visa at Indian Mission.
- $5.\ Not\ available\ to\ Diplomatic/Official\ Passport\ Holders\ or\ Laissez-passer\ travel\ document\ holders.$
- 6. Not available to individuals endorsed on Parent's/Spouse's Passport i.e. each individual should have a separate passport.
- 7. Not available to International Travel Document Holders.









On pressing "Pay Now", the application will be redirected to Payment Gateway to pay the visa fee and will be outside the control of Visa Online Application. The responsibility of security of transaction process and details on payment page will be of Payment gateway. Bank Payment Gateway accepts both OTP (One Time Password) and non-OTP transactions.

In case of any issue, please contact your Bank. Application ID will be blocked after three failed attempts of payment, in such case applicant has to apply again. On pressing "Pay Later", you can pay the visa fee later using your Application ID and date of birth.

Please note that your application for e-Visa will not be submitted without fee payment. It should be done prior to 4 days of Journey date.

All travelers seeking admission to India under the e-Visa (e-Visa) scheme are required to carry printout of the Electronic Travel Authorization (ETA) sent through email by Bureau of Immigration.

If your e-Visa application is approved, it establishes that you are admissible to enter India under the e-Visa scheme of the Government of India. Upon arrival in India, records would be examined by the Immigration Officer.

Biometric Details (Photograph & Fingerprints) of the applicant shall be mandatorily captured upon arrival into India. Non-compliance to do so would lead to denial of entry into India. A determination that you are not eligible for e-Visa does not preclude you from applying for a regular Visa in Indian Mission. All information provided

by you, or on your behalf by a designated third party, must be true and correct.

An Electronic Travel Authorization (ETA) may be revoked at any time and for any reasons whatsoever. You may be subject to legal action, if you make materially false, fictitious, or fraudulent statement or representation in an Electronic Travel Authorization (ETA) application submitted by you. The transaction cannot be cancelled or amended once the fee has been paid.
